- seek a costs assessment under section 198 or a binding determination under sections 99 or 192 of the *Legal Profession Uniform Law* (Uniform Law);
- seek a costs assessment before the Supreme Court Costs Court under Division 7 of Chapter
 4.3 of the Uniform Law;
- make a complaint to the Victorian Legal Services Board and Commissioner (VSLBC) under Division 1 of Part 5.2 of the Uniform Law within 60 days after the legal costs were payable or, if an itemised bill was requested in respect of those costs, within 30 days after the request was complied with.

You may be able to make a complaint to the VLSBC up to 4 months after the end of the period referred to. This is provided that you can satisfy the VLSBC that it is just and fair to do so, having regard to the delay and reasons for the delay, and provided that legal proceedings have not been commenced for the recovery or review of the legal costs that are the subject of the complaint.

INTEREST

We advise that pursuant to section 195 of the Uniform Law and our costs agreement, we
may charge you interest at the Cash Rate Target, as fixed by the Reserve Bank of Australia,
plus 2%, on any amount outstanding on this tax invoice from 30 days after you receive it until
the amount is paid in full.
